The widely accepted material are 35 Gsm & 43 Gsm in SMS. 3. It is requested to please specify the exact sizes as specifying only S/M/L gives very generic dimensions and may result in disqualification in technical evaluation desired sizes are not matched. We request you to please specify the exact length and width of the gowns required. Mode of packing is also a bit unclear as the pack size stated in the tender is 20 pcs per pack. So if sterile gowns are packed in this mode, once opened sterility of all will be lost at the same moment. Thus it seems a bit irrelevant to pack them in 20 pcs mode. Our recommendation would be single piece packing in medical grade peelable paper pouches.
